ARTICLES OF INCORPORATION
OF
National Organization
of
Circumcision Information Resource Centers

ONE: The name of this corporation is National Organization of Circumcision Information Resource Centers.

TWO: This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Benefit Corporation Law for charitable purposes. The specific purposes for which this corporation is organized are the disseminating of educational material, the providing of instruction, and the organization of an information and research exchange in the public interest and for the education of parents, health-care professionals and others on the subject of the practice of routine circumcision.

THREE: The name and address in the State of California of this corporation's initial agent for service of process is Marilyn Milos, R.N., 2 Grant Street, Woodacre, CA 94973.

FOUR:

(a) This corporation is organized and operated exclusively for educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

(b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or by (2) by a corporation contributions to which are deductible under 170(c)(2) of the Internal Revenue Code.

(c) No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

SIX: The property of this corporation is irrevocably dedicated to educational purposes meeting the requirement of S214 of the California Revenue and Tax Code and no part of the net income or assets of the organization shall ever inure to the benefit of any Director, officer or member thereof or to the benefit of any private person.

On the dissolution or winding up of the corporation, its assets remaining after payment of all debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for educational purposes meeting the requirement of S214 of the California Revenue and Tax Code and which has established its tax-exempt status under Section 501(c) (3) of the Internal Revenue Code.
