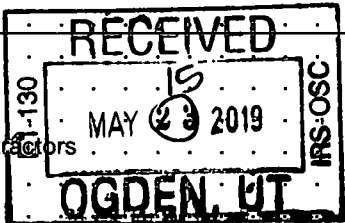

Our events train demonstrators to do street theatre, leading by example in the use and design of effective signage, advocacy to passers-by, and distribution of educational info.
